Should you have more than two children, please utilize a second form that you can either obtain from the school or download from the AACPS website at www.aacps.org. Also, please note that complete address Parent/Guardian's Employer if they work on Federal Property, the complete address of the Federal Property on which they work, and each survey form must be sianed and dated Parent/Guardian. The Federal Impact Aid Survey form for 2019-2020 will be available to download on September 30, 2019. We will also be using our Connect-Ed Automated Telephone Notification System to remind everyone about the significance of completing and returning this survey. The school system receives approximately \$2 million in funding from the Federal government in support of our children after the forms are processed.
