Overview

- ➤ 128 schools serving approximately 85,000 students
- > \$1.69 billion FY25 Operating Budget

Bid Procedures

- Category I: Less than \$5,000 Competition at the discretion of the buyer
- ➤ Category II: \$5,000 to \$25,000 Requires three quotes
- > Category III: More than \$25,000 Requires competitive bidding process

Minority and Small Business Enterprise (MBE) Program

- > Overall MBE goal of 29% for State-funded capital construction projects
- Overall MBE goal of 15% for all other contracts.

How to do Business with AACPS

- Register as a vendor on the AACPS website to receive bid notices. https://bids.aacps.org/viw
- Solicitations over \$25,000 and contract award notices are advertised on the AACPS website and eMaryland Marketplace Advantage. https://emma.maryland.gov/page.aspx/en/usr/login?ReturnUrl=/page.aspx/en/buy/homepage
- AACPS vendors must be in good standing with the MD Department of Assessments and Taxation. http://dat.maryland.gov
- AACPS contractors and subcontractors may not employ registered sex offenders and certain other criminal offenders to work at a school. Certain contractor employees hired to work on an AACPS contract are subject to mandatory screening procedures.
 - See section 11-722 of the Criminal Procedure Article, and sections 6-113 and 6-113.2 of the Education Article, Annotated Code of Maryland.
