


There are 120 small homes in our county that serve as housing for our elderly residents with the least money. According to a representative from the

Department of Aging, at least 70% of the residents have NO money left after all their income from Social Security and pensions is taken to pay the monthly fee of \$3500 - \$4000. The remaining individuals have less than \$50.00 for toiletries and maybe an occasional candy bar. With rising costs, the homes are struggling to remain open.
