

All of these different facets of my life will bring a rich and diverse experience that will enhance the Board of Education's resources. My role as a member of the Board is to ensure that all student's needs at AA county schools are reflected in the policies AA county Board of Education approves.

I believe overcrowding in the schools is a challenge. I believe with creative thinking and budgeting that the school board may be able to find additional solutions to change the current situation.
